(a) Misrepresentation of information set forth in an application for permit; (b) Non-compliance with the conditions, restrictions, or provisions on which a permit is issued; (c) a change or erasure on a permit.

The permittee shall be responsible for damages to the roadway, to persons, and to property caused by or arising from operations covered by this permit. The permittee shall indemnify and save harmless the Clinton County Road Commission, its commissioners, and employees from any and all suits, claims, and damages of every kind arising out of, under, or by reason of this permit, or from operations covered by this permit.
